• PROGRESS REPORT OF THE YEAR 2019-20

Mr. Himanshu Juyal, the Organizing Secretary welcomed the house and with the permission of the chair read the progress report of the organisation as follows:

- 1. Parivartan Public School:** This is fifth session of the school although the enrollment is not very high and the school is facing a big financial problem and The Hans Cultural Centre has not done any financial support to the school so far as declared during the session 2016-17 although continuously assuring through its Uttarakhand head Mr. Padmendra Singh Bisht. The Patron and President of the organisation only supported the school expenditures so far. Therefore the coming time may be crucial and require support to run the school properly. The school has been affiliated still up to 8th standard.

3. **Plantation and Environmental Development:** This year the organisation has managed tree plantation with itself and under MNRGA 600 plants of pomegranate and 500 plants of wild variety have been planted in the surrounding vicinity of the school campus and upside of the village Kanda. Fruit seeds are also sowed in the forest with expectation of their germination and fodder for the wild animals, same awareness has also been given to the local masses so to cope with the continuous problem of wild animals like Monkeys, Langurs and of wild boars which are disturbing the local economy and food production of the villages.
4. **Water Conservation:** The organisation has continued its water conservation works this year through collaborating with MNEREGA without any monetary support so the village panchayats are requested to follow the program to make trenches, check dams, chal khals upside of the villages so to conserve rain water properly and increase the ground water level also.
5. **Awareness Programmes:** The organisation motivated rural people to start cash crops like spices i.e. chilli; coriander, ginger, turmeric and medicinal herbs to increase their economical capacity. The land has become more barren than last years so these vast barren areas can be used to grow fruit orchards, herbal gardens or for horticulture activities to generate income for the villagers.
6. **Health Awareness:** The organisation is continuously working to aware local villagers about hazards related to smoke from kitchen chulhas and so promoting smoke less chulhas that the organisation introduced during COMDEKS project. The organisation has also supported various government and nongovernmental programs in the area such as free health checkups done by the Hans Foundation at the local public health centre Kot.
7. **Earth Day:** The organisation usually each year celebrate such days of awareness therefore this year also a rally was organised on 22nd April by school students, villagers, volunteers and members to create awareness among the masses and bad effects of plastic and polythene were administered at the celebration.
8. **Solid and Liquid Waste Management Program:** Under the government programme 'SWAJAL' the organisation has been working in 12 Gram Panchayats of Kot block, Pauri Garhwal. In this programme the works like awareness and software development are being performed by the organisation satisfactorily. The villages are Tonkhya, Dhammund, Chaproli, Sirala, Paali, Kandola, Gairolgaon, Panchur, Lasera, Taidi, Kanda Van and Ranakot. The budget are allotted to the Gram Panchayats so the working agency are the same and the organisation acts as a facilitator or a support agency to them. Approximately 80-90% work has been completed so far.

Mrs. Savita Dave will be our member working voluntarily abroad. There will be further more meetings in this matter if required for authorization and other.
2. **Mr. Harish Sharma:** He is another member who is interested to work with the organisation among his corporate sector voluntarily to get support for the initiatives or objectives of the organisation. He may be a board member in near future.

EXPECTED PROGRAMMES OF 2020-21:

The organisation will continue its all works regularly and search the adequate support to run its all activities properly. The board members and other members are requested to work according to their capacity for the strengthening of the organisation so that it could properly enhance the activities and could make a change in the society according to their requirements. Basically there are near about 60 students in Parivartan Public School and its annual expenditures is near about 10 lacs. Most of students are poor and need help. The Principal, Vice Principal and Admn Head are not getting any honorarium due to lack of fund and rest teachers are being given on 50% of their honorarium.

Especially Smt. Savita Dave, the donor member is requested to generate funds to support students who are very poor, orphan, destitute and kins of deceased (Road accident survivors, Widows etc.) or honorarium part of the teachers.

We also request Mr. Harish Sharma to generate funds from corporates or individuals to promote the activities like Solar power generation, LED bulbs, Electric or Electronic gadgets and bio fuel making from Pine leaves in recent future.

The organisation has also to develop the opportunities to start boarding facilities for weaker section students along with their studies. More areas of concern are promotion of Horticulture, Nursery, Animal Husbandry etc to generate income and provide employment to local youths.
